JESSICA AUCHTER is Assistant Professor at The University of Tennessee at Chattanooga. Her research focuses on visual politics and culture. Her book, *The politics of haunting and memory in International Relations* (2014), examines the politics and ethics of being haunted by lives, deaths and dead bodies.
