TATIANA CARAYANNIS is Deputy Director of the Conflict Prevention and Peace Forum at the Social Science Research Council and Senior Visiting Fellow at the London School of Economics. She is the co-editor of *Making sense of the Central African Republic* (with Louisa Lombard, 2015) and co-author of *UN voices: the struggle for development and social justice* (with Thomas G. Weiss and Louis Emmerij, 2005). She is currently working on three new books, *The logic of public authority: justice and security in Central Africa*; *Pioneers of peacekeeping: ONUC 1960–1964*; and *Authorities in conflict in the DRC*.

IAN CLARK is Honorary Professor, School of Political Science and International Studies, University of Queensland. He is also Emeritus Professor of International Politics at Aberystwyth University where he was, until 2014, the E. H. Carr Professor. Many of his books have been on problems of international legitimacy, including *Legitimacy in international society* (2005) and *The vulnerable in international society* (2013). He recently completed an entirely re-written edition of *Waging war: a new philosophical introduction* (2015). He is a Fellow of the British Academy, and an Honorary Fellow of Selwyn College, Cambridge.

TRACEY GERMAN is a Reader in the Defence Studies Department at the Joint Services Command and Staff College, King's College London. Her research focuses on Russia's relations with its neighbours, including its use of force in the post-Soviet space, and conflict and security in the Caucasus and Caspian region. Her publications include *Regional cooperation in the South Caucasus: good neighbours or distant relatives?* (2012) and *Russia's Chechen war* (2003), as well as articles in journals such as *European Security*, *Europe-Asia Studies*, *Small Wars and Insurgencies*, *Central Asian Survey*, *Vestnik analitiki* and *Politique étrangère*.

NIGEL GOULD-DAVIES teaches at Mahidol University International College in Thailand and is an Associate Fellow of Chatham House. He taught at Oxford University before joining the Diplomatic Service, where he served as Ambassador to Belarus and project director in the Policy Planning Staff. He later worked in the international energy industry. His work has appeared in *Foreign Affairs*, *Diplomatic History*, *Washington Post*, *Nikkei Asian Review*, *Vedomosti* and other publications. He is completing a book on global political risk.

RENÉE JEFFERY is a Professor of International Relations at Griffith University in Brisbane, Australia. Her research focuses on human rights and post-conflict justice in the Asia–Pacific, international ethics, and the role of the emotions in international relations. Her most recent works include *Amnesties, accountability and human rights* (2014), *Reason and emotion in international ethics* (2014) and, with Hun Joon Kim, *Transitional justice in the Asia–Pacific* (2013). Williams, she is the co-author of, among other books, *Challenging gender norms: women and political activism in times of crisis* (2013); and co-editor of *Women, gender equality, and post-conflict transformation: lessons learned, implications for the future* (2017).

NAZRIN MEHDIYEVA specializes in Russian energy, security and foreign policy. She advises international organizations, governments and companies, and has over a decade of experience informing high-level decision-making in the private sector on energy security. Her book entitled *Power games in the Caucasus* was published in 2011.

NICOLA PHILLIPS is Professor of Political Economy and the Head of the Department of Politics at the University of Sheffield. She was the Chair of the British International Studies Association (BISA) in 2015–16, and has served as Editor-in-Chief of the journal *New Political Economy* and one of the editors of the *Review of International Political Economy*. She works in the field of global political economy, with interests focusing on global economic governance, inequality, labour in global production, and migration and development. Between 2010 and 2013, she held a prestigious Major Research Fellowship from The Leverhulme Trust, for research on forced labour and human trafficking for labour exploitation in the global economy.
