MOHAMED-ALI ADRAOUI is a Senior Fellow at the Middle East Institute at the National University of Singapore and a Marie Curie Fellow at the School of Foreign Service at Georgetown University. Previously, in 2013–15, he was a Max Weber Fellow at the European University Institute. His research is concerned with the history and development of Salafism as well as Islamist movements' foreign policies, and the US foreign policy towards political Islam. He is the author of *Du golfe aux banlieues. Le salafisme mondialisé* (2013; English and Arabic versions are forthcoming). He also edited *Islamism and foreign policy: ideology in practice*, to be published in 2018.

JEAN-PIERRE CASSARINO is a political scientist conducting research at the Institut de Recherche sur le Maghreb Contemporain (IRMC, Tunisia) on migration issues and international relations. Previously, he held a professorship at the Robert Schuman Centre for Advanced Studies, European University Institute (RSCAS, EUI) where he supervised interdisciplinary research projects on return migration policies, mobilizing EU and non-EU partner institutions (in Africa, the Mediterranean and the Caucasus). He also worked for the International Labour Organisation. Among other journals, he has published in *The Middle East Journal*, *Politique Étrangère*, *The International Spectator* and the *European Journal of Migration and Law*; and is the editor and author of books such as *Readmission policy in the European Union* (2010) and *Unbalanced reciprocities* (2010).

RAFFAELLA A. DEL SARTO is Associate Professor of Middle East Studies at the Paul H. Nitze School for Advanced International Studies (SAIS), SAIS Europe at Bologna, Johns Hopkins University. She is also part-time Professor at the European University Institute, Robert Schuman Centre, where she directed the research project 'Borderlands: Boundaries, Governance, and Power in the European Union's Relations with North Africa and the Middle East', funded by the European Research Council. She previously held research fellowships at the University of Oxford and the European University Institute. She is the author of *Contested state identities and regional security in the Euro-Mediterranean area* (2006) and *Israel under siege: the politics of insecurity and the rise of the Israeli neo-revisionist right*, which has just been published (2017).

LOUISE FAWCETT is Professor of International Relations and Wilfrid Knapp Fellow and Tutor in Politics at St Catherine's College, University of Oxford. She is currently head of the Department of Politics and International Relations. Her

She was previously a Visiting Scholar at the Centre of Middle Eastern and Islamic Studies, University of Cambridge; and the inaugural John Vincent Visiting Fellow at the Department of International Relations, Research School of Pacific and Asian Studies, Australian National University. She has published in leading journals such *Nations and Nationalism*, *Third World Quarterly*, *Critical Studies on Terrorism* and *Global Discourse*; and is the author of *Turkey facing East: Islam, modernity and foreign policy* (2013).

THOMAS HÜSKEN is Senior Research Fellow at the Department of Ethnology of the University of Bayreuth. He has been working on tribal politics in the borderland of Egypt and Libya. His current research project is titled 'Political Orders in the Making: Emerging Forms of Political Organization from Libya to Northern Mali'.
